IA NOS. 158707 AND 158709/2023 (APPLNS. FOR DIRECTIONS AND EXEMPTION FROM FILING O.T. ON BEHALF OF DR. SHARAD GUPTA)

1. This is an Application (IA No.158707/2023) for directions.

Prayer 'b' of the Application reads thus:

"Pass the order to declare Agra as Heritage Site as direction issued by this Hon'ble Court vide its order dated 19.12.1996 and 28.08.2018."

There is nothing placed on record to show that by declaring

Agra as a world heritage site, there will be any special advantage to the city. Moreover, we do not think this Court can grant a declaration as prayed that Agra is a heritage site. The Application (IA No.158707/2023) is rejected. Consequently, IA No. 158709/2023 also stands disposed of.

IA NO. 31946/2024 (APPLN. FOR PERMISSION ON B/O OF NORTH CENTRAL RAILWAY, AGRA)

- 1. We have perused the affidavit filed by the Union of India in compliance with our order dated 11th July, 2024. In terms of the said order, we expected the concerned Authorities to constitute a team of experts with a direction to the team of experts to visit the site of the project and redo the exercise of ascertaining as to how many trees are really required to be cut for implementation of the project. This exercise has not been done as can be seen from the affidavit filed on 7th September, 2024.
- 2. We direct the Union of India to take necessary steps. We grant time of three weeks to file an affidavit in those terms.
- 3. List on 27th September, 2024.
