- **01.** Instant petition has been filed in the name of J&K High Court Bar Association, Srinagar through Mr. Arshad Andrabi, Advocate S/o Ghulam Qadir Andrabi, R/o B-2 Gulberg Coop Colony, New Airport Road, Peerbagh, Srinagar, one of its Executive Members. However, this petition was later on treated as Public Interest Litigation.
- **02.** Response has been filed by the respondents raising preliminary objections with regard to locus as well as maintainability of the present petition. It is apt to reproduce paragraph Nos.3 and 7 hereunder:-
 - "3. That the petitioner association has no locus standi to challenge the impugned amendment as no larger public cause is projected by the present proceedings.
 - 7. That the petitioner association has not followed the relevant rules governing filing of PIL petition in the Hon'ble High Court. In this regard reference is inter alia, made to rule 24(4) (VII) of the writ proceedings rules, 1997. The said clause reads as under: -
 - "....Before filing a PIL petition, the petitioner must send a representation to the concerned authorities for taking remedial action to enable the concerned authorities to take appropriate action. Details/copies of such representation and reply, if any, must be filed

along with the petition. However, in urgent cases,

petitions can be allowed to be filled without any such

representation. In such cases, the petitioner must give

prior notice of filing of petition to the concerned

authorities and/or their standing counsel, if any....."

03. Mr. D.C Raina, learned Advocate General submits at the Bar that the

petitioner is neither authorised association nor has been registered under the

Jammu and Kashmir Societies' Registration Act, therefore, present

petition/PIL is not maintainable.

04. Perusal of the record appended with this petition/PIL reveals that the

petitioner has not attached any certificate showing that the petitioner is a

registered society. On this ground only, the present PIL is not maintainable as

the petitioner-association has no locus to file the same in the name of Jammu

and Kashmir High Court Bar Association, Srinagar.

05. In view of stand taken by the respondents in the counter affidavit and

the submissions made by Mr. D.C Raina, learned Advocate General, this

Public Interest Litigation is not maintainable as the petitioner-association has

no locus standi to file the same in the name of J&K High Court Bar

Association, Srinagar and as such, the same is, dismissed, accordingly.
