

The Issues agitated and the reliefs claimed in all these Original Applications are more or less identical. Therefore the above Original Applications were heard together and disposed of through this common order. It is agreed upon that O.A.No.81 of 2020 can be considered as leading case. The reference with respect to Annexures mentioned hereinafter are in the order in which they are produced in the said case.

2. The applicants in all the cases are Anganwadi Workers (Awws) working under the Women and Children Welfare Development Department of the State Government

(formerly the Social Justice Department). The applicants are persons holding Degree qualification. The basic issue agitated is with respect to fixation of specific quota (ratio) for appointment to the post of Supervisor (ICDS) from the category of Awws, under the Integrated Child Development Scheme (ICDS). The Special Rules governing service of Awws, which prevailed till amendment effected during the year 2012, was the Special Rules for the Kerala Social Welfare Subordinate Services, 2010. The post of Supervisor (ICDS) was included in category No.13 in the said Rules. As per the method of appointment provided under Rule 3 of the said Rules, the post of Supervisor (ICDS) has to be filled up by recruitment from Awws who possess the qualification of SSLC and 10 years' experience as Awws under the ICDS Scheme in the Social Welfare Department. But under the said Rule a ratio of 70:29:1 was stipulated from the feeder categories in between open candidates, Awws and feeder categories, respectively. By virtue of Annexure A2, the Special Rules was amended in the year 2012. The effect of

the amendment incorporated is that, the method appointment with respect to Supervisor (ICDS) stood modified as only through direct recruitment through selection by the Public Service Commission (PSC). A change In the ratio (quota) provided in the Special Rules of 2010 was brought into effect. The ratio was changed through the amendment, as 58:29:11:2 in between (i) open candidates, (ii) Awws, (iii) Awws having Degree in any subject and (iv) by promotion from the feeder categories, respectively. In the amendment it was clarified that the new ratio will come into force only with effect from 01.01.2014 and the 11% out of the enhanced ratio of 40% earmarked to the Awws, is allowed to those who are having Degree qualification from that date onwards. It is clarified that the ratio of 58:40:2 will apply till 31.12.2013, without any differentiation between the Awws who possess Degree qualification and SSLC qualification. In other words, the revised ratio is declared as applicable only with effect from 01.01.2014, in

between the Degree holders and SSLC holders among the Awws.

3. It is not in dispute that the Special Rules as it stood amended is applicable with respect to recruitment to the post of Supervisor (ICDS) with effect from 01.01.2014. Evidently the PSC had conducted selection to the post of Supervisor (ICDS) based on Notification published under Category No.423/2014. Annexure A1 ranked list was brought into force with effect from 19.07.2017. According to the applicants, selection conducted by the PSC was for direct recruitment under the quota (ratio) earmarked for Awws with Degree qualification. Subsequently the PSC issued Annexure A10 Notification inviting applications for selection to the post of Supervisor (ICDS) by way of direct recruitment from Awws having not less than 10 years' experience. It is specifically contended that, despite the specific ratio stipulated at 11% for Awws holding Degree qualification, no selection was conducted by the PSC with

respect to the said quota after the ranked list published as per Annexure A1.

- 4. The applicants point out that, the Central Government (Union Government) in the Ministry of Women and Children Development Department had issued Annexure A3 circular on 15.09.2015, addressing all the Government Secretaries dealing with the Scheme in all the States and Union Territories stipulating guidelines for recruitment of Supervisor (ICDS). The guidelines stipulated for appointment to the post of Supervisor (ICDS) is that, 50% of the vacancies in the post of Supervisor (ICDS) need to be filled up by appointment from amongst Awws with 10 years' experience and possessing the prescribed educational qualifications as per the recruitment rules for the post. The remaining 50% vacancies in the post of Supervisor (ICDS) need to be filled up by direct recruitment.
- 5. Contention of the applicants is that, there occurred failure in implementing the directions contained in Annexure A3 Circular by the State of Kerala, as there

to the Special Rules, to change the method of appointment through 50% promotion and 50% direct recruitment. It is evident that the applicants in various groups have different approached in the State Government representations during different occasions. In the year 2017 some among the applicants along with others have approached this Tribunal by filing O.A.(Ekm)No.2919 of 2017. Through Annexure A5 order passed on 19.01.2018 this Tribunal directed the State Government to consider the representation submitted by the applicants therein and to take a decision thereon within a period of three months from the date of receipt of a copy of that order. It is evident that, in the said representation, fixation of the ratio for graduate Awws at 11% is pointed out as an anomaly, considering the guidelines formulated by the Central Therefore it was requested to be rectified. Government. Annexure A6 is the consequential order issued by the State Government in the Social Justice Department, dated

05.05.2018. Taking note of the directions contained in O.A.(Ekm)No.2919 of 2017, the matter was considered after affording opportunity of personal hearing to the applicants therein. It was observed in Annexure A6 that a committee was already constituted through an order issued by the Director of Social Justice Department, dated 30.10.2017, in order to suggest amendments to the Special Rules; and that the 1st respondent had issued directions to the Director of Social Justice Department to report the vacancies earmarked for Degree holders among the Awws.

of 2017 was issued by this Tribunal in another case,
O.A.(Ekm)No.2189 of 2018, as per Annexure A7 order
passed on 22.11.2018. In yet another Original Application
filed before this Tribunal, O.A.No.849 of 2019, it was
submitted on behalf of the Government that the matter is
pending before the Director of Social Justice Department
and that proceedings were already initiated to amend the
Special Rules in accordance with the directions issued by the

ONAL Gentral Government. In that case also this Tribunal directed the Director of Social Justice Department to consider the grievances of the applicants therein while forwarding the proposals for amendment of the Special Rules to the State Government. But in Annexure A9 order, dated 19.02.2019, purportedly issued in compliance with the directions contained in Annexure A8 order of this Tribunal, the Government again directed the Director of Women and Children Development Department to examine the matter and to take appropriate action for revising the existing ratio in the mode of recruitment to the post of Supervisor (ICDS), when submitting a draft proposal for amending the Special Rules. But, despite the lapse of more than 5 years as of now, no amendment in tune with the directions issued by the Central Government through Annexure A3 is effected. Therefore the Original Applications are filed seeking appropriate directions.

7. Another challenge raised in some of the Original Applications is against the steps initiated by the respondents

:: 9 :

to make appointment of Supervisor (ICDS) on a provision basis, under Rule 9(a)(i) of the Kerala State & Subordinate Service Rules 1958 (for short KS & SSR) by inviting list of sponsored candidates from Employment Exchanges. It is contended that the posts are filled up on provisional basis through candidates advised from the Employment Exchanges, it will seriously prejudice the prospects of the applicants for being promoted to the post of Supervisor (ICDS). Moreover it is contended that, when specific method of appointment is stipulated through the Special Rules, the steps taken for effecting provisional appointments, without reporting the existing vacancies to the PSC for selection and advice, is highly illegal and unsustainable. Initially, this Tribunal through an interim order passed on 02.02.2021 stayed the steps for filling up of the posts of Supervisor (ICDS) on provisional basis through the Employment Exchange. But subsequently the said order was modified by this Tribunal on 18.03.2021, directing the respondents to provisionally fill up the

vacancies of Supervisor (ICDS) by providing provisional PONAL Promotion to the qualified departmental hands. respondents were directed to pass orders on or before It was further observed that any further 05.04.2021. vacancies if available, this Tribunal will consider issuance of appropriate direction to fill up them provisionally through the Employment Exchange. The interim order passed by this Tribunal on 18.03.2021 was subjected to challenge before the Hon'ble High Court in O.P.(KAT)No.140 of 2021 and connected cases filed, at the instance of the State Government and its officials. Through an elaborate judgment passed by the Hon'ble High Court on 24.08.2021 the matter was remitted back for consideration of all relevant aspect by this Tribunal, based on the pleadings to be adduced illustrating the vacancy position. However, in a statement filed by respondents 1 and 2 on 27.09.2022, it is mentioned that, based on the interim order passed by this -Tribunal on 02.02.2021, the 2nd respondent has kept in abeyance all further steps for appointment of Supervisor

(ICDS) on provisional basis through Employment Exchange and that no provisional appointment was effected through the Employment Exchange in the category of Supervisor (ICDS).

It is evident that the recruitment process 8. initiated by the PSC for selection to the post of Supervisor (ICDS), through Annexure A10 Notification (Category No.311/2019), was completed and the ranked list was already published. In a batch of Original Applications filed before this Tribunal, there was challenge raised against the selection process. The question agitated was as to whether Awws holding Degree qualification are entitled to apply for the post of Supervisor (ICDS), notified in the category of 29% ratio earmarked for the Awws with SSLC qualification The question was possessing 10 years' experience. ultimately decided by a Full Bench of this Tribunal through order passed on 01.04.2024 in O.A.No.1821 of 2022 and connected cases. Relying on the provisions contained in Rule 10(a)(ii) of Part II KS & SSR and also considering the :: 12 :

fact that the qualification of Degree is a higher qualification fact that the qualification of SSLC, it was ultimately held that the Awws holding Degree having the requisite experience are also entitled to apply for selection under the quota earmarked for Awws with SSLC qualification (in the 29% quota). It is further evident that a subsequent recruitment process was initiated by the PSC under Category No.149/2022 for filling up the post of Supervisor (ICDS) under the quota earmarked for Degree holding Awws, within the 11% ratio fixed. Learned Standing Counsel for the PSC submitted that ranked list with respect to the said selection was published on 24.02.2024.

- 9. Heard; counsel for the applicants in various Original Applications, Government Pleader appearing for the official respondents and Standing Counsel appearing for the PSC.
- 10. From the factual aspects discussed as above, the only issue remaining to be adjudicated and decided is with respect to implementation of the guidelines (directives)

of the Central Government, Issued through Annexure A3 Circular, to the extent of specifying that, posts of Supervisor (ICDS) shall be filled up, by promotion from Awws with 10 years' experience with respect to 50% of the vacancles, and through direct recrultment with respect to the remaining 50%. It is evident that the directions in this regard was issued by the Government of India in the Ministry of Women and Children Development Department, as early as on 15.09.2015. The applicants in these Original Applications as well as various other similarly situated incumbents have repeatedly approached this Tribunal when their request to modify the Special Rules In accordance with Annexure A3 guldelines were not acceded to by the State Government, As mentioned hereinabove, repeated directions were issued by this Tribunal through various orders passed as per Annexures A5, A7 and A8 directing to take an appropriate decision, considering the representations submitted in this regard. In Annexure A6 order Issued by the Government as early as on 05.05.2018, It was stated that the matter is in

Spizin of the Director of Social Welfare Department and a Committee was constituted to consider the proposal for amendment. In Annexure A9 order issued by the Government subsequently on 19.02.2019, it is reiterated that the State Government had issued directions to the Director of Women and Children Development Department to examine the case and to take appropriate action for revising the existing ratio, in the mode of recruitment of Supervisor (ICDS), while submitting draft proposal for amending the Special Rules. But it remains a fact that nothing has turned out with respect to modifying the ratio, as suggested in Annexure A3 guidelines.

11. Learned counsel for the applicants contended that the directives contained in Annexure A3 has got binding force on the State Government and that the State Government has got a statutory obligation to implement those stipulations. It is pointed out that the legislative power on the subject matter is vested concurrently on the Union Government and the State Governments, as the

subject matter is included in List III of the Seventh Schedule of the Constitution of India (concurrent list). Therefore it is contended that the decision of the Central Government in this regard will prevail and the State Government will be bound to implement it. We cannot accept such a contention since Annexure A3 circular is not having any statutory force either as a Rule or as a Regulation framed by any statutory authority. At the same time, as contended by the learned counsel applicants, the Scheme in question, viz., the "Integrated Child Development Scheme (ICDS)" is being implemented and monitored by the Central Government with participation of the State Governments and Union It is also contended that there is financial Territories. participation of both the Governments in implementation of the Scheme. Therefore any directions issued by the Central Government for effective implementation of the Scheme need to be considered by the State Government for implementation, if necessary by amending the Special Rules. The State Government is showing lethargic attitude

regard, despite repeated assurances made through Annexures A6 and A9 orders. Presumably the matter is being prolonged by the State Government as there is no time limit stipulated in Annexures A5, A7 or A8 orders passed by this Tribunal. However, until a final decision is taken in this regard, the Special Rules will govern service conditions of the applicants and they will be entitled to get appointed to the post of Supervisor (ICDS) only in accordance with the ratio as stipulated in the existing Special Rules. It is pertinent to notice that, by virtue of the common order passed by this Tribunal in O.A.No.1821 of 2022 and connected cases, dated 01.04.2024, the applicants who are working as Awws with 10 years' experience and having the qualification of Degree are declared as entitled to compete for selection in the total quota (ratio) of 40% (29+11).

Under the above mentioned circumstances, the above Original Applications are hereby disposed of by directing the State Government in the Women and Children

Department to take appropriate decision with respect to amending the Special Rules in tune with the guidelines issued by the Central Government under Annexure A3, as promised in Annexures A6 and A9 orders, at the earliest possible, at any rate, within a period of three months from the date of receipt of a copy of this order.
