


# Launching The Legal Mentorship Program

**Avani** Bansal finished her Masters in Law from Harvard Law School and B.C.L. and M.Phil in Law from the University of Oxford. She is currently practising as an Advocate in the Supreme Court of India, New Delhi and is the Founder of an eponymous chamber – Avani Bansal Chambers (ABC). She had earlier worked with Senior Advocate, Harish Salve. She won eight gold medals at Hidayatullah National Law University (Raipur, India). At Harvard, she received the Dean's Award for Community Leadership and was the elected LL.M. Class Representative. At Oxford, she presided over Oxford Lawyers Without Borders, while being an Associate Editor with the Oxford University Commonwealth Law Journal.

Avani is passionate about gender issues and women rights in India. She is the Founder of India's first digital newspaper for women – The Womb. As part of her legal awareness drive, she presents 'Hamara Samvidhan' – on 'The Wire' – a weekly show where she explains the Indian Constitution in Hindi. She also runs her own legal awareness YouTube channel 'Hamara Kanoon'. She appears regularly on Live Law and writes regularly for Times of India, The Leaflet, Live Law amongst others. She is also a TEDx speaker. Avani has authored a book -'Life At Law School' which is published by Eastern Book Company, wherein she shares her experience of eight years spent at law schools, including Oxford and Harvard. She extensively lectures students across colleges and schools in India, sharing tips on cracking lvy league universities and talking about legal reforms needed in India today.





### 1. Can first and second year law students apply for this course?
