The Recruitment Coordination Committee for the Batch of 2024 [“**RCC**”] takes immense pride in announcing the successful culmination of the recruitment season. The RCC achieved a record **100% placement**, as has been the trend of NALSAR recruitment, **by securing the placements of its 86 (eighty-six) subscribers** at domestic and international law firms, various corporate houses, and government entities by the end of June 2024.

The RCC successfully catered to the varied career choices of the students and welcomed diverse organisations for conducting recruitment. We would like to express our gratitude towards the entities that share a longstanding relationship with us and continue to believe in the competence of the students of NALSAR. We further extend our gratitude to the entities that recruited students from our pool of subscribers for the first time this year and look forward to building a strong relationship with them in the future.
