Respected Lordship,

On behalf of the entire association, I respectfully request that the supplementary cause list should include the hearing sequence for all the courtrooms for the next day, enabling better planning and preparation for our members.

The present practice of issuing the order of Sequence in the morning after 10:30 am is causing enormous challenges for all the AORs, Non-AORs, Seniors, Juniors, clerks etc. as a whole. The elderly members of the bar and those who are not technically very adept are bearing the brunt and are frequently unable to attend hearings of their matters. Adding to the problem, it is unfortunate that some Courts are declining to give Passovers in the first round which is a matter of great concern and causing great difficulty to the members of the Bar.
